GLADWIN COUNTY MECHANICAL FEES

Item #2, Residential Heating System: This item is used for the installation of a heating system in a **new residential structure**. Item #11 - Gas piping and #25 - Duct, **SHOULD NOT BE** charged. Replacement systems should be itemized.

Item #4, Residential Boiler: A residential boiler must be installed by a licensed boiler installer.

Items #16 and #18, Tanks: A homeowner must own tank to install. If homeowner does not own tank, a licensed mechanical contractor must install tank.

IX. Instructions for Completing Application

General: Mechanical work shall not be started until the application for permit has been filed with the Gladwin County Construction Codes Department. All installations shall be in conformance with the Michigan Mechanical Code. **No work shall be concealed until it has been inspected.** The telephone number of the Mechanical Dept./inspector will be provided on the permit form. When ready for an inspection, call the office providing as much advance notice as possible. Have the township, address & property owner's name when scheduling.

Expiration of Permit: A permit remains valid as long as work is progressing and inspections are requested and conducted. A permit shall become invalid if the authorized work is not commenced within six months after issuance of the permit or if the authorized work is suspended or abandoned for a period of six months after the time of commencing the work. **A PERMIT WILL BE CLOSED WHEN NO INSPECTIONS ARE REQUESTED AND CONDUCTED WITHIN SIX MONTHS OF THE DATE OF ISSUANCE OR THE DATE OF A PREVIOUS INSPECTION. CLOSED PERMITS CANNOT BE REFUNDED OR REINSTATED.**
